This is my Report recommending the vesting of Crown land at Registration Section West Bay Beach South, Block 13C Parcel 1 (part) to **THE TRUSTEES OF THE CAYMAN ISLANDS RUGBY CLUB CHARITABLE TRUST** in accordance with Section 10 (1) (b) of the above Law. It is accompanied by the documents required pursuant to Section 10 (2) of the said Law which contain the details of the proposed vesting.

REPORT OF THE CHIEF OFFICER, MINISTRY OF EDUCATION, YOUTH, SPORTS, AGRICULTURE & LANDS

VESTING OF CROWN LAND BLOCK 13C PARCEL 1 (Part) TO THE

TRUSTES OF THE CAYMAN ISLANDS RUGBY CLUB CHARITABLE TRUST

Block 13C Parcel 1 comprises a 47 acre Parcel of land that is predominantly in use as part of the George Town landfill site. However, the 1.32 acre western extremity of the Parcel was severed by construction of the Esterley Tibbetts Highway, and accordingly is separated from the portion of the Parcel used for landfill. The Highway now forms the western boundary of the landfill.

Cabinet has approved that a 0.51 acre portion of the western severed part of Block 13C Parcel 1 be vested to the Trustees of the Cayman Islands Rugby Club Charitable Trust by way of the grant of a 99 year lease at a peppercorn annual rent. The land to be leased to the Trustees is landlocked and cannot be accessed directly from the Highway. The land was originally zoned Public Open Space but was rezoned to High Density Residential in keeping with the zoning of the surrounding land to the west.

The subject land will form a part of a 13 acre sports facility that the Trustees of the Charitable Trust propose to develop at this location, principally for rugby but also designed to accommodate cricket. 12.5 acres of the site are being leased to the Trustees from a Dart affiliate land-holding company, for 99 years at a peppercorn rent, and it is proposed that the Government replicate these terms in its grant of the subject lease for the remaining 0.5 acre portion of Crown land that forms the final piece of the site.

Maps of the land to be leased, with a proposed design superimposed are attached to this report.

A report on this matter was considered by Cabinet. After careful analysis and consideration of the reports provided it was resolved (1187/42/18, 4th September 2018) that the Governor in Cabinet approve the vesting of Crown land Block 13C Parcel 1 (part; approximately 0.51 acres) to the Trustees of the Cayman Islands Rugby Club Charitable Trust, by way of the grant of a 99 year lease at a peppercorn annual rent for a use restricted to not for profit sporting facilities.

Given that there will be only a nominal 'peppercorn' rent payable under the terms of the lease, the Governor in Cabinet has waived the requirement for valuations to be obtained for this Report to the Legislative Assembly, pursuant to the authority contained in Section 10 (3) of The Governor (Vesting of Lands) Law, (2005 Revision) on public interest grounds.

Accordingly, the vesting of Crown land Block 13C Parcel 1 (part) is recommended on the following terms and conditions:

Lessor: The Governor of the Cayman Islands.

Lessee: The Trustees of the Cayman Islands Rugby Club Charitable Trust

Property: Block 13C Parcel 1 (part only). **Area:** Approximately 0.51 acres.

Consideration: Nominal annual peppercorn rent only.

Use: Not for profit sporting uses only

Other: Lease not transferable, lease subject to the Lessee obtaining

planning consent.

Costs: Each party to bear its own costs.

Stamp Duty: Not waived.





RESOLUTION

SECTION 10 (2) (e) GOVERNOR (VESTING OF LANDS) LAW, (2005 REVISION)

PROPERTY KNOWN AS LAND LOCATED OFF THE ESTERLEY TIBBETTS HIGHWAY, GRAND CAYMAN - BLOCK 13C, PARCEL 1 (PART)

Whereas:

- 1) The Trustees of The Cayman Islands Rugby Club Charitable Trust have applied to lease Crown land Block 13C Parcel 1 (part only).
- 2) The area proposed for lease comprises approximately 0.51 acres and is a part of the portion located west of the Esterley Tibbetts Highway.
- 3) After careful analysis and consideration Cabinet has advised the Governor that it is in the best interest of the Cayman Islands to grant a lease to the Trustees of The Cayman Islands Rugby Club Charitable Trust for a term of 99 (ninety nine) years at a peppercorn rent for use as a not for profit sporting facility.

IT IS FURTHER RESOLVED that full details of the property and of the disposition proposed shall forthwith be published in the Cayman Islands Gazette and a local newspaper and that copies of this entire resolution and of the said advertisements in the Gazette and in the newspaper, together with all other items required for the purpose of the said Section 10 (except for valuations, the requirement for which shall be waived) shall be laid on the table of the Legislative Assembly by the Minister responsible for land.
