Private Member's Motion No. 1 of 2023:

IMPLEMENTATION OF A PROGRESSIVE INCOME TAX SYSTEM IN THE CAYMAN ISLANDS

WHEREAS it is acknowledged that there is no current income tax system in the Cayman Islands;

AND WHEREAS the strength of divides between socioeconomic class income in the Cayman Islands disproportionately disadvantages lower-income households;

AND WHEREAS wealth disparity in the face of high prices for food, housing and utilities could have a destabilising impact on the economy and quality of life for middle and low income Caymanians;

AND WHEREAS low income households are disproportionately impacted by a high cost of living;

AND WHEREAS implementation of a progressive style of income tax can improve access to education (early childhood through to tertiary), housing, healthcare, safety nets, and security for the Cayman population;

AND WHEREAS in order to tackle socially-corrosive issues like inequality and wealth disparity the Cayman Islands needs to create an economy distributive in nature;

BE IT THEREFORE RESOLVED THAT this Honourable Youth Parliament considers the implementation and maintenance of a progressive income tax system that encourages stronger equity of wealth for all Cayman Islands' citizens.

Private Member's Motion No. 2 of 2023:

IMPLEMENTING A NEW PUBLIC TRANSPORTATION SYSTEM IN THE CAYMAN ISLANDS

WHEREAS personal vehicle dependency and traffic problems in Grand Cayman are seriously affecting the lifestyle of the citizens and the environment of the Island;

AND WHEREAS the current public transport system and its infrastructure are not adequate to cater to an island of over 75,000 people;

AND WHEREAS there are no reliable alternative means of transportation, for those citizens who either don't own personal vehicles, are unable to use their vehicles, or simply wish for an alternative means of transport;

AND WHEREAS the citizens of Grand Cayman are in dire need of a proper and reliable public transport system;

AND WHEREAS there is no incentive for persons to decrease the number of personal-use vehicles;

AND WHEREAS there is no deterrent to persons owning multiple vehicles;

BE IT THEREFORE RESOLVED THAT this Youth Parliament Government considers implementing a comprehensive public transport system with related infrastructure, features, and incentives.
