~~Whereas~~ section 47(1) of the Constitution of the Cayman Islands provides that the Governor may at any time, by Proclamation, prorogue or dissolve the Legislative Assembly of the Cayman Islands;

~~And Whereas~~ section 47(2) of the Constitution of the Cayman Islands provides that the Governor shall dissolve the Legislative Assembly of the Cayman Islands at the expiration of four years from the date when the Legislative Assembly first meets after any general election unless it has been sooner dissolved;

~~And Whereas~~ article 3(1) of the Cayman Islands (Constitution) (Amendment No. 2) Order 2004, S.I. 2004 No 2673, provides that notwithstanding section 47(2) of the Constitution of the Cayman

Islands, the Governor shall dissolve the present Legislative Assembly of the Cayman Islands no later than 17th March 2005:

Now, Therefore, I, Bruce H. Dinwiddy,

Companion of The Most Distinguished Order of St. Michael and St. George, Governor of the Cayman Islands, by virtue of the powers conferred upon me by the said section 47(1) and (2) of the Constitution of the Cayman Islands and the said article 3(1) of the Cayman Islands (Constitution) (Amendment No 2) Order 2004, S.I. 2004 No 2673, **HEREBY PROCLAIM** that the Legislative Assembly of the Cayman Islands shall be dissolved as from Tuesday, the 15th Day of March, 2005.
