1. **Reference**

Following the Second Reading of the Supplementary Appropriation (January 2020 to December 2020) Bill, 2022 and the Supplementary Appropriation (January 2021 to December 2021) Bill, 2022 the Bills stood committed to the Standing Finance Committee of the Parliament in accordance with the provisions of Standing Orders.

In accordance with the provisions of Standing Order 64(7) the Standing Finance Committee agreed that the Chairman report to this Honourable House the Appropriation changes in accordance with Section 25 of the Public Management and Finance Act (2020 Revision) in respect of the financial years stated in the previous paragraph.

2. **Composition of Committee**

In accordance with the provisions of the Cayman Islands Constitution Order 2009, Section 71(7), the Standing Finance Committee comprises all Elected Members of the Parliament with the Honourable Minister of Finance as Chairman of the Standing Finance Committee.

3. **Consideration of Supplementary Appropriations**

The Committee had before it the 2nd Supplementary Plan and Estimates for the financial year – 1 January, 2020 to 31 December, 2020 and the 1st Supplementary Plan and Estimates for the financial year – 1 January, 2021 to 31 December, 2021.

The Committee met on Thursday, 15th December, 2022, to consider the Schedules of the Supplementary Appropriation Bills for 2020 and 2021 Financial Years, further supported with additional details set out in the Supplementary Plan and Estimates documents, in accordance with Section 25 of the Public Management and Finance Act (2020 Revision).

The Minutes of the meeting are appended hereto and form part of this Report.

The Committee met again on Thursday, 15th December, 2022, to consider and approve this Report.
