Supplementary Appropriation (January 2022 to December 2022) Bill, 2023

Wednesday, 7th June, 2023

Laid upon the Table of this Honourable House this 8th day of June, 2023 by the Chairman of the Standing Finance Committee, Minister of Finance.

1. Reference

Following the Second Reading of the Supplementary Appropriation (January 2022 to December 2022) Bill, 2023, the Bill stood committed to the Standing Finance Committee of the Parliament in accordance with the provisions of Standing Orders.

In accordance with the provisions of Standing Order 64(7) the Standing Finance Committee agreed that the Chairman report to this Honourable House the Appropriation changes in accordance with Section 25 of the Public Management and Finance Act (2020 Revision) in respect of the financial year stated in the previous paragraph.

2. Composition of Committee

In accordance with the provisions of the Cayman Islands Constitution Order 2009, Section 71(7), the Standing Finance Committee comprises all Elected Members of the Parliament with the Honourable Minister of Finance as Chairman of the Standing Finance Committee.

3. Consideration of Supplementary Appropriations

The Committee had before it the 1st Supplementary Plan and Estimates for the financial year -1 January, 2022 to 31 December, 2022.

The Committee met on Wednesday, 7th June, 2023, to consider the Schedule of the Supplementary Appropriation Bill for the 2022 Financial Year, further supported with additional details set out in the Supplementary Plan and Estimates document, in accordance with Section 25 of the Public Management and Finance Act (2020 Revision). The Minutes of the meeting are appended hereto and form part of this Report.

The Committee met again on 8th June, 2023, to consider and approve this Report.

5.
