1. INTRODUCTION

AND BE IT FURTHER RESOLVED THAT the Standing Business Committee shall comprise six Elected Members;

AND BE IT FURTHER RESOLVED THAT the quorum for the Committee shall be four Members of the Committee including the Chairman and that the Committee shall meet at such times as called by the Chairman;

AND BE IT FURTHER RESOLVED THAT the Committee review its terms of reference and report any recommendations to this Honourable House.

1. Meeting to Order

The Chairman welcomed and thanked the Honourable Members for attending the Meeting. There being a quorum present, the Chairman brought the meeting to order at 12:10 pm.
