1. INTRODUCTION

The Parliament appointed the Standing Business Committee with the passing on 23rd April 2021 of Government Motion No. 1 and resolved that –

- (f) to inform the Clerk the order in which Bills shall be set down upon the Order Paper;*

AND BE IT FURTHER RESOLVED THAT the Standing Business Committee shall comprise six Elected Members;

AND BE IT FURTHER RESOLVED THAT the quorum for the Committee shall be four Members of the Committee including the Chairman and that the Committee shall meet at such times as called by the Chairman;

AND BE IT FURTHER RESOLVED THAT the Committee review its terms of reference and report any recommendations to this Honourable House.

1. Meeting to Order

The Chairman welcomed and thanked the Honourable Members for attending the Meeting. There being a quorum present, the Chairman brought the meeting to order at 10:10 am.

The Chairman advised that the purpose of the meeting was to approve the Business of the House for the First Meeting of the 2023-2024 Session of the Parliament commencing Tuesday, 19th September, 2023.
