Thank you for allowing me the opportunity to bring to the attention of this Honourable House, the exceptional circumstances appropriation changes which have resulted in the Supplementary Appropriations initiated by the Ministry of District Administration & Lands for 2024 and 2025.

Mister Speaker, Cabinet considered and approved the following requests for Section 11(5) appropriations in accordance with the Public Management Finance Act (2020 Revision) by the Ministry of District Administration & Lands appropriation lines so as to satisfy the 2024 and 2025 expenditure needs as follows:

EA 42 – Cayman Brac and Little Cayman: Street Lighting Mister Speaker, Cabinet approved the increase of

*EA 42 – Cayman Brac and Little Cayman: Street Lighting*, in the Ministry of District Administration & Lands by Fifty Thousand Cayman Islands Dollars (CI\$50,000) via Section 11(5) of the Public Management and Finance Act (2020 Revision), to facilitate the installation in order to complete light pole installation at Big Channel Bluff Road, Clemensthyme Drive, Myrtle Jane Drive, and Oscar Drive in Cayman Brac. The aforementioned increase in *EA 42 – Cayman Brac and Little Cayman: Street Lighting*, by Fifty Thousand Cayman Islands Dollars (CI\$50,000) was the result of the decrease in EI 87 Ministry of District Administration and Lands Equity Injection by Fifty Thousand Cayman Islands Dollars (CI\$50,000).
