STATEMENT BY HER EXCELLENCY THE GOVERNOR, HELEN M. KILPATRICK, CB

Her Excellency the Governor: Members of the Legislative Assembly, Ladies and Gentlemen, good morning.

I am very honoured to be taking part in this Swearing-in Ceremony this morning. My congratulations go to all Elected Members of the Legislative Assembly as they take their seats today. I would particularly like to congratulate those Members who have taken on the responsibility of serving our people as an elected representative for the first time. And I would

also like to thank those candidates who were unsuccessful for making their contribution to the democratic process. This is a historic ceremony this morning because it is the first time the Legislative Assembly has been elected under the new single member constituency system.

I was very pleased that the Cayman Islands once again invited the team of election observers from the Commonwealth Parliamentary Association (CPA) to oversee the conduct of this election, and that their overall conclusion that the 2017 General Elections of the Cayman Islands amply met the International Standards democratic genuine and transparent elections. This is a testament to the exemplary work of the Supervisor of Elections, Mr. Wesley Howell, his office and the many volunteers who supported the process. We are very fortunate to have such a capable and dedicated elections team and thank all of them for their excellent work.

We should also thank the Royal Cayman Islands Police Service and the Special Constabulary who turned out at full force to ensure that electors felt safe and secure as they cast their votes (thank you, Commissioner); that the highest ever, number of voters registered for this election and the high turnout at 74 per cent shows how engaged the systems of the Cayman Islands are in this democratic process.

Elected Members of the Legislative Assembly, you are privileged to have been chosen by our people to represent them. I know that you will want to justify the faith that has been placed in you by fulfilling your leadership roles with probity, with passion, and with the best interest of the Cayman Islands' people firmly in your hearts. No doubt there are challenges ahead for the Cayman Islands over the next four years of this parliamentary term. I am confident that you will all rise to these challenges and lead the Cayman Islands to an even brighter and more prosperous future.

I am only sorry that I will not be here beyond the first year of this new Parliament but I look very much forward to working with you all of my remaining time in the Cayman Islands and I wish you every success.

PROCLAMATION NO. 3/2017

The Clerk: Cayman Islands Proclamation No. 3 of 2017 by Her Excellency Helen Marjorie Kilpatrick, Companion of the most Honourable Order of the Bath, Governor of the Cayman Islands.

WHEREAS section 83 (1) of the Constitution of the Cayman Islands provides that the sessions of the Legislative Assembly of the Cayman

Islands shall be held at such places and begin at such times as the Governor may from time to time by Proclamation appoint;

NOW, THEREFORE, I, Helen Kilpatrick, CB, Governor of the Cayman Islands, by virtue of the power conferred upon me by the said section 83 (1) of the Constitution of the Cayman Islands, hereby proclaim that a session of the Legislative Assembly of the Cayman Islands shall be held at the Legislative Assembly Building in George Town, in the Island of Grand Cayman, beginning at 10 am on Wednesday the 31st day of May 2017.

Given under my hand and the public seal of the Cayman Islands at George Town, in the Island of Grand Cayman, this 29th day of May, in the year of our Lord, Two Thousand and Seventeen, in the sixty-sixth year of the reign of Her Majesty Queen Elizabeth II.

The Speaker: Honourable Members, I am most humbled to have received your support to be elected to this high position of being the Speaker of this honourable Legislative Assembly. I thank you for your trust and confidence in me as the longest serving Member of this Legislature, and if I should say so myself, indeed, of any other, in the life of our parliamentary democracy in these Islands.

When I entered this Assembly in 1984 the presiding officer was the Governor of these Islands. The Governor of these Islands was also the president of the Executive Council, the forerunner to our Cabinet. It was an untenable situation indeed, for me and fortunately for others who shared my thought process of the true separation of the Executive and Legislative Authority.

We, the men of real understanding and intelligence of the trappings of the colonial administration, Mr. Roy Bodden, Mr. John Jefferson Jr., Mr. Gilbert McLean, Mr. John McLean Sr., the late Mr. Haig Bodden, and the worst or strongest conservatives of the conservatives, Mr. Truman Bodden, all banded together to vote for a motion piloted by myself and seconded by Mr. Roy Bodden, to get and independent Speaker of our Legislative Assembly.

I will never forget, Honourable Colleagues that on the tally of the votes and the motion which seemed like no one thought would ever be passed in this House because we had done that at least three times before that, but on that tally, we could have struck with a striker and not a drop of blood, as the Governor in this Chair had to accede to the vote of 7 Ayes and 4 Noes thereabouts. We had won the day on our historical motion for an independent Speaker of this honourable Legislative Assembly. Well, was I happy? I was overjoyed that on our motion, history was made.

Down through the years for me it was not about the power of our Speaker. That was and is the point. Responsibility is the point and at the heart of responsibility, always are good moral choices. In what we do, in what we say and what we stand for, we must feel as did our ancestors that it is the examples of our Islands that matters.

Should the world see us as what? Willing to trample one another? Willing to destroy each other, cursing, lying, belittling, and damaging our own character? Then my friends, honourable colleagues, what are we then, but a game-stock for those who prefer to see us in the worst light; so, here we are at roughly seven days away from where our people utilised their franchise to elect a governing body of 19 Members of us to conduct the affairs of these Cayman Islands.

Friends, we have joined together, some of us, to come together with the People's Progressive Movement and the number of Independents to form a Government of National Unity. The negotiation to arrive at this position was very difficult. It took several diversions but, in the end, we believe there is a Government which will serve the interest of the people of the Cayman Islands. So, we therefore want to call all of our Members, our supporters, friends and well-wishers to support this new Government of National Unity in the interest of all Caymanians and these Cayman Islands. We are mindful that we have asked for several things which the Premier and his Cabinet and Executives will pay respect to.

The result of the elections has highlighted the need for greater political co-operation in order to meet the expectations and aspirations of the people of these Islands. And so, we have committed to immediately work together to resolve a number of matters of concern to the people of the Cayman Islands and we look forward to the Premier and his Cabinet working with us to resolve the many issues that strike at the heart of our people. No need to ask if it can be done

my friends, colleagues, it must be done. We have no time to play the politics of one-upmanship. Our people are depending on us, our people need help, and so, in our national life we do not need fanfare, we need less fanfare to speak the truth, to work harder and stay faithful to our fundamental beliefs. Someone said we are, each of us, responsible for our own actions, but we all know it has been bedrock in our own individual life, that without co-operation, without all of us working together pulling together, we cannot make it. And, honourable colleagues we need all of you; your gifts, your energy and your ideals. We are here to serve our people, not to make mountains out of molehills and destroy opportunities of goodwill and hope.

My role—I was in the Speaker's Office by myself and I said, My God, what have I done? What a lonely place this is. My role as Speaker is not only as the arbiter but I am also an interpreter of regulation. I am not a disciplinarian but, in a way, a judge inspired by fundamental principles and guided by a proven jurisprudence of the House. The latter is not, however, unchangeable, it is in fact, honourable Members, up to us to change or let it fall into abeyance if we feel it no longer corresponds to our present situations so, understand, please, my approach will be realistic and pragmatic. I will recognise that I must act in a humane environment where Members are called upon to make increasingly complex decisions. It is easy to criticise and find fault, and in so doing, to disrupt business in this honourable Chamber. Well, this is where, as Speaker, I can be political without being partisan but must take into account both the letter and spirit of our Standing Orders and regulations. And I stress if need be, the most natural rule, that of common sense.

Honourable Members, I say what I have said makes sense. It is this: Our Islands are at a crossroad. We have had our elections. The issues we face are great. Democracy must now work for our people all of our people. I am sure that this Government which I have chosen to help form, a Government of National Unity, recognises that the same old—same old—will not suffice in this Twenty-first Century. I believe our Premier wants to move forward. I believe he wants to get the job done and we all want that as well. My job is not only to facilitate the rules of free speech and protect the minority, which I will do, if they will allow me to. But understand this: I am here in this time of our existence of the people, to help ensure that our Government is able to carry out their job and to carry out their responsibilities. And so, I will not tolerate efforts to stall or impede the Government's progress. We have had too much of that in our time. It is time to move forward of the problems we face, to fix those problems and allow our Caymanian people and all others who live and move and have their being with us, to succeed; our children and grandchildren, our prodigy to live content lives in these Cayman Islands. I know that is what the PPM [People's Progressive Movement] wants and that is what our Independent

Members want and by God that is published statement of what my CDP [Cayman Democratic Party] wants better for our people.

Mr. Premier and all Honourable Members, I am your Speaker. You have put me here. It does not change my persona. My desire is to see our systems work. I will not tolerate unnecessary holdups and the wasting of precious time for the sake of feeble attempts to weary our Government into frustration. I have been there my friends. I have been there. This is my ninth term. I know what an Opposition can do and I know what is expected of a government and we must now move forward (if I should say in simple West Bay parlance-no time for rowing now!). So, let us endeavour to do good; yes, to make a difference. I am of that good generation, raised on the idea that we as a people can do just about anything we set our minds to do. This is our Cayman Islands, "Founded Upon the Seas and Established Upon the Floods" and long may She reign in peace and prosperity.

Just one last word: This Legislative Assembly, as much as the public does not know, is probably at the bottom of the pile in the Civil Service. We do not have sufficient tools to do the job in this modern day when everybody is cursing Members and saying, We want better from you. Well, my dear Caymanians in this audience today, go and spread this word; we have to have all of the necessary tools, each and every Member of this Legislative Assembly. So, the Civil Service have to rethink their position. And this Legislative Assembly staff, some who have been here over 30 years, will be treated differently if I can muster the support to get it done. We are a modern Cayman, proud we must be. Let us take this Assembly and make it be what it can be and what it needs to be.

New Members I will only say to you how I ran with my family. My wife has never been on the political platform in 40 years. She has been a good door keeper and so she, in her own way helped. Keep your family out of politics, tend to your children and don't let them get involved. All of you, particularly the young ones will be tempted. You have done well to be elected and we are proud of you. Those who are not Members of my party, we are holding you in high esteem from where you have come to where you are.

God bless all of you. Treat me good. Treat me good.

[Laughter and applause]

ADDRESS BY THE HONOURABLE PREMIER

The Premier, Hon. Alden M. McLaughlin, Jr.: Thank you.

Your-Excellency, Ministers and Members of the Cabinet, my Elected Colleagues in the Legislative Assembly, Chief Officers, Ladies and Gentlemen, good afternoon.

Before I start my address I just want to note that for the first time in my political career and the five times I have been sworn in, my dear father was not able to attend and I know he is watching on television, so dad. I miss you.

I want to begin my address today with the words of Franklin D. Roosevelt, former President of the United States. He said: "Competition has been shown to be useful up to a certain point and no further, but cooperation which is the thing we

must strive for today, begins where competition leaves off."

It is in the spirit of cooperation that this new Government of National Unity has been formed; cooperation for the greater good of all our people of these Cayman Islands. In this regard, I am especially thankful to the Members of the Cayman Democratic Party and the Independent Members who put country before self or party to join with the Progressives to form the Government. I give the country the assurance that all Members of this Government are equal partners at the table.

Over the course of the past week things have at times felt chaotic but actually, this process of negotiation and testing the strength of various potential coalition has been a necessary one. I believe it has yielded a government that will deliver stability and advance the interest of the Cayman Islands and our people over the next four years. I can tell you that this has easily been the longest week of my political life. I thought in 2000 when I was first elected was bad but no brother, there were some days that even I scarcely knew what to expect from one hour to the next. Every time I blinked there was another proposal on the table.

There were also some light moments for us though, as my team met to consider the options and recounted the events of the campaign to help ease the tension. And one such story is so good that I thought I would share it with you today. It involved on election-day, one of our biggest supporters dragging her husband out of the shower to vote for one of our candidates and throwing him into the backseat of her car with only a half-shaven face at just ten minutes to six o'clock. He went to the polling booth with one side of his face shaved and the other with hair still on it.

[Laughter]

The Premier, Hon. Alden M. McLaughlin, Jr.: I can report that he cast his vote within the time allowed by the law and was duly driven back home to continue shaving. The only regret is that his vote did not save our candidate. And through this all there have been, just today, some notably encouraging things.

I want to thank and pay due homage to the new Leader of the Opposition, the Honourable D. Ezzard Miller, for having come to me this morning and essentially saying to me— "The battle is the battle but the battle is now over and we need to move this country forward". And then when I thought it could not get any better, somebody showed me the *Compass* editorial—We are all in your corner, Mr. Premier.

The Premier, Hon. Alden M. McLaughlin, Jr.: Forming a government is not about meeting a swearing-in deadline or settling old scores. It is about bringing to-

gether a team that can work together and stay together for a common purpose. I believe we have invited and have been joined by those most capable of meeting these essential requirements. The elections are now over. Thank God.

As in all elections, there are winners and losers, but as Roosevelt points out, we are now past the point of competition. There is undoubtedly still hurt and disappointment in some quarters. It is one of the unintended consequences of the democratic process that we hold so dear. However, in the same way that as a country we showed the world we could conduct free and fair elections, I am confident that as Caymanians, we will also demonstrate our maturity, duty and commitment to the national good by working together to move our country forward. I do not single out only those honourable Members who have been elected to represent the 19 Electoral Districts across these three Islands, but all of us, Government and governed, together as Caymanians. It is the only path that will guarantee national and individual success and prosperity.

There are some, both within and outside of this honourable House, who may wonder of even question whether political opponents can unite to direct the affairs of our country. The truth is that there is much common ground among us. Our common objectives to protect the vulnerable provide opportunities for our people to give them a better quality of life, ensure that our Islands remain safe and secure for both residents and visitors, to manage the continued growth and stability of our economy, our commitment to transparency and good governance and to responsive and inclusive representation, give us a mutual platform on which to integrate policy positions. There may be some differences in style but not in substance. As a new Government we respectfully ask for the public's trust and your confidence in us to do what is right by you. This is a Government of inclusion that is committed to representing all Caymanians.

The honourable Members who have chosen to unite for the common good are to be commended for their sense of duty and selflessness. I believe that each and every one of us recognise that the first requirement of political office is representation. It is on that basis that we were elected. Our next obligation is leadership. We can only fulfil this second duty as a cohesive unit working together for the common good. It is this to which we have all committed here today.

Government is not a prize to be won by smooth talkers and social media gurus; it requires earnest attention to the things that make a difference to the lives of our people. It demands the ability to discuss freely differences in opinion while resolving to work together towards a common goal. It imposes respect and abandonment of egos. It also requires loyalty to the people and to their welfare. I am able to offer these insights through personal experience as the leader of the previous coalition government. I do

not have any fears that this Government will be any different. Cooperation must be the core of our outlook if we all desire success as we embark on this new term of office. I also have enough experience to know that it will not all be smooth sailing. There are some genuine policy choices to be made about how growth is best supported and benefits shared about which the Progressives, the CDP and the Independent Members have traditionally differed. It will challenge us to work through those differences. But the process of doing so will, I believe, lead to potentially better decisions. I look forward to robust but ultimately fruitful debate within the context of a Government of National Unity.

Despite these differences, I have seen and heard most, if not all, of the policy positions espoused during the campaign by those who now form the Government. Each of us acknowledged that the efforts of the previous government to improve the prospects of our young people through education and training must be redoubled. We are at one with the need to provide better opportunities for Caymanians in the workforce. We know the importance of financial services in tourism to our economy. There is no division on the imperative of a prudent well-managed economy. We value both local and foreign investment in the economy. We recognise the advantages in moving to a green economy and protecting our environment. We are all committed to the growth of small business and fostering a spirit of entrepreneurship among Caymanians. We share the same desire to put people at the centre of the decision-making process and to represent the interest of our constituents. These are just some of the broad elements that define our mutual objectives for the country. I therefore wish to assure everyone that across the political spectrum the views of the electorate will be respected and represented by this new Government of National Unity.

At this point, I must reflect that the outcome of the elections was nearly very different. Had 15 voters in Newlands cast their ballots differently and 35 had done so in George Town Central, then, my former Government would have won 10 seats and an outright majority. By such slim margins are things decided in a democracy and, certainly, I have no intention of dwelling on the 'might-have-been'. Rather, as Premier, I will embrace the opportunity that the voters have given us for a different approach to governance. Before doing so, I hope you will forgive me if I reflect for a moment on some of those who will not be part of the new Government. For a variety of reasons, three of my former Ministers have not been returned at this election. I want to thank them for their service and put on record my appreciation for their contribution made during the last term.

[Applause]

The Premier, Hon. Alden M. McLaughlin, Jr.: It is significant that although they will not be part of the

new Government, their influence will still be important as we build on the legacy they have left. On behalf of the Progressives that are a part of this new Government, I say without hesitation, that our duty is to country first, from East End to West Bay and all points in between; Cayman Brac and Little Cayman. No one who means the country well will be left behind.

I also take this opportunity to publicly thank my colleagues for their unwavering support in the face of all sorts of external pressure and inducements over the last few days. This Government has a lot of work to do if we are to address the key issues facing our people. We will not shirk from that and in joining me, each of my 12 colleagues has committed to working together to find and implement the solutions we need.

Given the nature of the coalition it will take us some time to develop our comprehensive four-year programme for government. As I said before, I am sure there will be some robust discussions along the way and I am looking forward to that process. I guarantee it will be an inclusive one.

While this is a Progressives-led Government, it is a genuine coalition that will respect the contribution that each partner can make.

[Applause]

The Premier, Hon. Alden M. McLaughlin, Jr.: I am hopeful that we will be able to present a programme to the country by the end of July. If it takes a little longer, then so be it. We will get it right rather than just meet an arbitrary deadline. The crucial point is that the programme will shape the budget decisions we need to make by December so that we can allocate the resources available to meet the priorities of the Government.

As the new Government settles in and agrees on its priorities to continue to build on previous successes, I ask for the prayers of the nation and God's guidance to ensure that the transition period will be smooth, short and reflective of the will of the people.

Cayman now has a new electoral system. I invite all Caymanians to become part of this new dispensation. I urge them to reach out to their representatives and get involved in their communities and their districts. Make democracy more than just casting your ballot every four years. The success of a country does not lie in the hands of the Government alone, but in the participation of its people.

[Applause]

The Premier, Hon. Alden M. McLaughlin, Jr.: We are a strong resilient people and we are CaymanKind. Hand in hand we have the potential to make the Cayman Islands not just good but great. From a personal perspective I am once more honoured to have been given the responsibility of leading this Government of National Unity. I give the country my assurance that I

am first and foremost a loyal Caymanian and I will continue to be guided by the principle of country before self. As someone who has been involved in public service since the age of 14, through my membership in Interact and later in the Lions Club, and as a Member of the Legislative Assembly, I wish to acknowledge all of the candidates who stood in this election. Whether or not they were successfully elected, they stood up when it mattered and for this they should be commended.

[Applause]

The Premier, Hon. Alden M. McLaughlin, Jr.: At election time there are 25,000 experts out there. Whatever a person's personal or political motivation may be, it takes courage to be part of the process and I thank them all for participating.

I also wish to thank everyone who took part in the electoral process by voting; those who volunteered to work on elections day, and especially the Supervisor of Elections, Mr. Wesley Howell and his hardworking staff.

[Applause]

The Premier, Hon. Alden M. McLaughlin, Jr.: I am proud to say that Cayman's electoral system and the way that we administer it, is regarded right across the region as the very best.

[Applause]

The Premier, Hon. Alden M. McLaughlin, Jr.: I offer Wes and his team our gratitude and congratulations on behalf of the country.

Before I take my seat, I must emphasise that this may be a coalition Government but it will not be a government of the lowest common denominator. We are a Government with ambition, determined to see Cayman make progress against the priorities and shared goals I have outlined. The nature of the coalition means I believe we have the right mixture of experience and fresh ideas needed to achieve our ambition. Regardless of our previous political labels, we are committed to working together to realise the potential that a Government for National Unity offers.

I thank the many people who offered prayers and have given the new Government words of support and encouragement. I thank the many pastors who have called or spoken to me or others, for your continued guidance, prayer and support.

On a personal note, my son, Daegan, is 25 today.

[Applause]

The Premier, Hon. Alden M. McLaughlin, Jr.: Happy Birthday Daegan. This is for you and your generation and the generations of Caymanians yet unborn.

May God bless us all and continue to bless our beloved Cayman Islands.

[Applause]

Ms. Kim Bullings: We will now enjoy a musical performance by Mr. Devon Edie.

Ms. Kim Bullings: We now invite Pastor Lavonne Ryan to say a prayer for the Cayman Islands.

Pastor Lavonne Ryan: An awesome day. We serve an awesome God. And God has given us an awesome country and he has made us an awesome people by the grace of God. Isn't that wonderful? Praise the Lord. Let's have a good praise, a good thank you to God for all of his blessings and mercies toward us.

Pastor Lavonne Ryan: He is faithful and he has come and has been faithful once more to the Cayman Islands.

Congratulations to all who make up the Government and to all of you, the people, who made it possible. Give yourselves a good hand.

To expound on that briefly, Mr. Speaker, it is the Christian heritage and culture and the preservation of sanctity of marriage as allowed in the Marriage Law (2010 Revision) and section 14 of the Constitution, as was approved by a motion that led and was unanimously accepted by the last legislature.

Mr. Speaker, this may not be the place but I must set my parameters from early. I have great concern of people like [Dr.] Raznovich in his attempt to insight residence to go out against our Constitution and the Marriage Law (2010 Revision). And I cannot understand—and maybe someone will explain to me when the House so desires—how a person who is here as a dependent, can interfere in the functions of these Islands.

Once again, I will ask the Honourable Premier for the replacement of the Chair of the Human Rights Commission, Mr. James Austin Smith, if he is still there. It is beyond my comprehension, Mr. Speaker, how a person who is a confessed atheist can objectively deal with matters in a predominantly Christian nation.

Another topic that I touched on in the campaign was the early bringing of the return of the Legal Practitioners Bill (whichever Minister is responsible for that), that it comes back in the proper perspective that will be beneficial to our young Caymanians.

I would just like to leave these couple of verses with this honourable House: 1 Peter 2-13:17 – "Make the Master proud of you by being good citizens. Respect the authorities, whatever their level; they are God's emissaries for keeping order. It is God's will

that by doing good you might cure the ignorance of the fools who think you're a danger to society. Exercise your freedom by serving God, not by breaking the rules. Treat everyone you meet with dignity. Love your spiritual family. Revere God, respect the government."

I would also like to say *ditto* to my colleague, the new Minister for Bodden Town East, in the remarks that he put forward of furthering the benefit of Cayman to our Caymanian people.

May God, bless us all.

The Speaker: The Member for East End.

Mr. V. Arden McLean, Elected Member for East End: Thank you, Mr. Speaker.

Mr. Speaker, today I took the Oath of Office for the fifth time; to serve the people of East End in the capacity of a representative in this honourable House.

Before proceeding to my remarks, I would like to thank God Almighty for his blessings upon me over these many years. I next want to thank the people of East End for returning me to this august body to represent them for the fifth time. I am humbled by the trust they have once again bestowed in me. I give them my solemn promise to continue to represent them with respect and to make every effort to ensure they get their due from this country.

I would also like to thank my family for their support over the many years of my public service. Only those who serve in these capacities know the sacrifices that families make in support.

Mr. Speaker, I would also like to thank my running mates, the Independents, for their support during the campaign process, and to congratulate those who were successful at the polls. For those who were unsuccessful, I urge them to continue their quest for the honour of representing the people of their constituencies.

Last but by no means least, I wish, through this medium, to extend my sincere appreciation to my committee for its unwavering and continued support.

This election, Mr. Speaker, was a historic one. For the very first time our elections process was conducted by way of the democratic universal method of one person, one vote. If that was not enough, we also placed candidates' pictures on the ballot for the first time. Contrary to the naysayers, our elections seemed to have gone without major hiccups. The voters returned 9 Independents, 7 PPM and 3 CDP. It is my understanding that in this election the lowest percentage of spoilt ballots, ever, were recorded. I believe that that can be directly attributable to the one person, one vote and the pictures on the ballots.

Despite claims of no major hiccups, Mr. Speaker, on elections day, there is more to be done to ensure other areas relating to voters and candidates are enfranchised or streamlined. We have been talking of amendments for too long. It is now time to re-

move much of the outdated qualifications for elected membership from our Constitution and Election Law.

Long overdue is the need to have our election management removed from the responsibility of the Governor also. I am yet to receive the observers report, but according to the newspaper reports, they seemed to have identified areas of weakness that many of us have been advocating for change for, for a very long time. My hope is that this Government, in its second term, will move with haste to have these addressed; the earlier, the better.

Another area that requires immediate attention which has been identified by the latest set of observers is that of election finance reform. Mr. Speaker, our elections have become a game of who can spend the most to get the government they want or need. This election, and by extension, post-election, in my opinion, was the worst. It was so bad that it was bordering on becoming nauseating and the people of this country should not settle for it. Special interest, and what appears like the American-style super PACs, were spending without regard for secrecy because they could do it. God forbid this continues.

In addition, our elections seem to have become controlled from overseas, for instance, this Government is now called a Unity Government as a nomenclature for the new formed friendship, which seems to have been styled from a document governed by the laws of Jamaica. However, the Government is now formed. We need to now ease the uncertainty that our country has endured over the last week. Our people were taken on a see-saw ride from anxiety to stunned, from happy to sad. My hope is that if this situation ever arises again, that we can resolve these matters with haste.

While I am reluctant to address my involvement in detail here, I can assure the public that my side of the story will be told as I have always done. Right now, there are other matters that I wish to address.

Mr. Speaker, this election has given our people the opportunity to reflect and take stock. The lack of attention by previous governments to the basic needs of our people has drawn sharp criticism from the masses. Coupled with that lack of attention, we also see an uneasy trend of a decline in societal and moral values, and a watering down of standards and principles we once held dear. This election, more than any other one, was crucial to the future of these Islands and our people, their children and grandchildren. The gap between the haves and the have-nots have widened over the last few years. Many of our people are falling or have fallen through the cracks because they do not occupy the environs of the middleclass of the one per cent group who are getting all the benefits from this country. If we do not correct the direction the country is going, we are going to be left with our hearts full and empty hands. The Government must put its back to the wheel and work immediately to correct this worrying trend. We are in the midst of a crisis that must be corrected now. Our country is at war against the system of violence and hatred. Our economy is badly weakened for those at the bottom. That is from a consequence of greed and irresponsibility on the part of some, but also our politicians' failure to make hard choices and to prepare our people for a new age.

At the same time, our social services programmes are unfunded and understaffed. And many of those in need, especially our elderly, are not receiving the help they so badly need to live a basic life. Homes have been lost and jobs lost are beyond the reach of Caymanians. Businesses shattered. Our health care is too costly; insurance costs have gone through the roofs; our schools fail too many; our immigration and labour policies are in shambles; our roads infrastructure has been neglected; laws to protect Caymanians have been ignored or when proposed changes are made it is to benefit the few. We must immediately commit to the reviewing and changing the laws that are outdated and unconstitutional which do nothing to enhance the lives of our people; laws that do not float boats while drowning our people. This Government must-must, as a matter of priority-demonstrate that they have the necessary compassion to help our people. They must shed the label of being concerned with and catering to the fat cats only. The Government has to shed that and it is now.

I also implore the Government in their second term to seek a new way forward based on mutual interest and mutual respect for those who have not been elected on the PPM or CDP ticket, to respect the wishes of the peoples' choice and unclench the fists of the election campaign. We are no longer at war. It is over. The people have spoken and you are the Government. You now have the responsibility to manage the affairs of this country. You are responsible for the distribution of the resources of this country. Do not try to punish your opponents by withholding the needs of the people submitted to the Government, as has been done in the past. I hasten to remind you that a government is for the people, by all the people. Punishing your opponents will only affect the people. Know that your people will judge you on what you can build, not what you can destroy.

I commit to playing my role in the continued development of my country; a country that I am extremely proud of, where others come to and want to make their home. We need to ensure it remains that way but its resources are not out of the reach of our people. Mr. Speaker, they too have a dream, a dream that they feel is attainable in the country of their birth. Our job is to help them reach it. And instill in the generations to come, the pride of being Caymanian. Our goal must be to try to renew that spirit of endurance, the values of hard work and the understanding that hard work is always—always—rewarded. We must instill in a nation that has known the meaning of per-

severance still, since being inhabited. We are required now to create a new era of responsibility and lead our country in a new beginning of resolve where all boats rise and there is equality for our people.

Mr. Speaker, when I entered these Hallowed Halls on the 15th day of November, 2000, I closed with a quote from the Prophet Gabriel and it reads:

"May the strength of God pilot us;
May the wisdom of God instruct us;
May the hand of God protect us;
May the way of God direct us;
May internal power be our support; and
May internal wisdom scatter the darkness of our ignorance." [UNVERIFIED QUOTE]
I thank you, sir.

SUSPENSION OF STANDING ORDER 10(2)

The Premier, Hon. Alden M. McLaughlin, Jr.: Mr. Speaker, I am weary, but I move the suspension of Standing Order 10(2) in order that the business of the House may continue beyond the hour of interruption.

The Speaker: The question is that Standing Order 10(2) be suspended in order that the business of the House may continue beyond the hour of interruption.

All those in favour, please say Aye. Those against, No.

AYES.

The Speaker: The Ayes have it.

Agreed: Standing Order 10(2) suspended.

The Speaker: I ask you all to try to be judicious so that we can go home.

[Laughter and inaudible interjections]

The Speaker: I know I did not hear that.

Thank you all.

Honourable Member for Newlands.

Mr. Alva H. Suckoo, Jr., Deputy Leader of the Opposition, Elected Member for Newlands: Thank you, Mr. Speaker, and I promise I will be brief.

I think we are all still very weary but I did not really want to give up the opportunity to just say a few words as this is the first time I have had the opportunity to speak publicly since elections day, and I could not pass up the opportunity to first thank God Almighty for bringing me back to this honourable Chamber for a second term.

I also want to take the opportunity to thank my committee and the many persons who worked with me in Newlands to secure the election there, and to become the First Elected Member for the Constituency of Newlands. This is a historic moment for all of our constituencies, except for North Side and East End that remains the same. But we are all the First Elected Members of our various single member constituencies and that is a moment to feel proud.

I also want to thank the Supervisor of Elections for what I thought was a fair and transparent election. I did not encounter too many issues that would have given me concern and I really want to thank them for being so well organized and getting us through that process.

Of course, I want to say a special thanks to my friends and family who not only supported me in any way they could, but also put up with me. I've had many conversations with people who offered advice and quite a few people whom I have gotten into arguments with. But it all was for the greater good and I appreciate it all.

I especially want to thank the young people, not just in Newlands but also in Savannah. I think my committee consisted of the majority—and I mean the vast majority—of individuals were under the age of 30. And for individuals who were relatively new to politics, not too interested in politics, they certainly took on a life of politics and got me through, so I really could not miss the opportunity to thank all of those young people.

I would like to congratulate the Honourable Premier on his second term as Premier in this honourable House, and, of course, you, Mr. Speaker, on your appointment as Speaker today. And, I must congratulate my colleague to my right, of his appointment as Leader of the Opposition. I will try to give him as much support as I can as his deputy, as we move forward together, being the official Opposition of this Legislature.

Mr. Speaker, we now have what is being called a Government of National Unity and it is ironic because I was actually having a discussion with a member who is on the committee of the elected Member for Savannah, about what we thought the best possible outcome for this country would have been. Surprisingly, that is what we came up with; a government consisting of all elements of candidates who were involved in this election. So, I was a bit surprised when that became the end result because I was obviously involved in much of that horse trading and negotiation that took place within the last week. And I must admit a lot of it is still a blur. I heard one Member comment on just how intense that was, and I really have to apologise to some of my constituents as I was not communicating, not answering the phone. But that

comes with that process when negotiating that intensely.

I had to say to a young man who criticised me: You know, we are not selling fish, we are not running a fish shop (as my colleague always says), we are trying to form a government so have a little patience. But I can understand the anxiety and the stress that the general public must have felt because they were not even involved in the discussions so they really had no idea what was going on.

Mr. Speaker, this country now needs healing and I could stand here and talk more about what went wrong with the negotiations, what I thought was wrong, what could have happened differently, but it is all behind us now. We need to move forward. Our country is still divided politically. I know, because I was in one of the toughest fights in this election race. And I know how divided Newlands became over this election of a single member in one single member constituency. I can only imagine what went on in other constituencies that I was not paying attention to. So, we do need now to focus on bringing our people back together. So, rather than to stand here or go on the radio through the talk shows and talk about what went wrong, I am going to ask all honourable Members of this House to put that behind us now and let us move forward. We are talking about a government of unity and the Opposition plays a role in that as well.

I am committed to treat my role as Deputy Leader of the Opposition with the dignity and respect that it deserves. I am not interested in opposing for opposition sake. I will continue to support the good things for this country that the Government brings, and I will also ensure that the Opposition puts forward good proposals for this country as well. And that is how I agree we need to move forward. We all work for what we consider to be in the best interest of this country. Sometimes what one person considers to be in the best interest of the country differs from what I think it is, but at the end of the day we are all motivated by the same thing.

So, we can agree to disagree, we can agree to argue, we can agree to put forward different viewpoints, but at the end of the day we all must be working towards the same goal and objective. We are all Caymanian. So, the time for campaigning is over. Thank God. The time for political differences is over. The time for all of that conflict and division is over and it is time for us to join together and do what is best for this country. And I just want to give my word to the people of the Cayman Islands, that that is what I am here to do.

I ask, Mr. Speaker, that the Government not lose sight of what we were fighting for. We went out and it was very confrontational and emotional, but it was because we all believe so strongly in what we were fighting for. We still have issues with education and labour. Our middle class is still challenged and our young people are still facing a tremendous

amount of issues. I could go on and on but it is not time for that today. I simply ask the Government to not lose sight of those issues. You all campaigned on them. I campaigned on them. Let's work together wherever possible to fix those issues because the people of this country voted for hope. They voted for representatives who could bring hope to them and their families. Let's never forget that.

The Speaker: Thank you, Honourable Member. Elected Member for George Town Central.

Mr. Kenneth V. Bryan, Elected Member for George Town Central: Thank you, Mr. Speaker.

The opportunity to say "Mr. Speaker" In these Hallowed Halls is an opportunity that I am so blessed to have. Firstly, I want to congratulate you, Mr. Speaker, on being the first Member of Parliament in the Cayman Islands to have covered every senior post in the Legislative Assembly which should be congratulated to the highest of heights.

I know I was told to be brief but there is so much to be said. Thankfully, my colleagues and those who are a part of the Government have covered most of it. So, I will go directly to giving public thanks to those who helped me to this place today.

The most important is that I would like to give thanks to God. After so many prayers on my knees and prayers by others who supported me, God made a way for me to be standing here today.

I want to say thanks to my wife, my kids, my mother and father and extended family for supporting me through a very difficult time of times when I could not answer the phone, times when my patience was low, times when I was just not around missing on very important memories.

I want to especially say a special thanks to my committee members who also took time away from their families and time away from their own entertainment to support a vision that we had together for George Town Central to give those voters and residents a voice. And it would be remiss of me not to mention two particular names: that first one being Mr. Edlin Moore who was by my side throughout the process when many others doubted my ability, and who stayed up many, many nights discussing, strategising and analysing thoughts and ways to better my constituency. Secondly, thanks to Dr. Steve Tomlinson who, when many did not believe in me, he believed in me. And he not only believed in me, but allowed the ability by way of finance to put me in this position because being an independent candidate I did not have the luxury of being a part of a party that had the finance from many different fronts. I want to say thank you to my opponent, the honourable Marco Archer, who is a good man. I really prayed so many nights and hoped that it would not have been him but the past is the past, and I wish him well, no matter what the circumstances are.

I also want to say congratulations to the current Administration which is made up of the 3 CDP Members, 4 Independent Members and 7 Progressive Members. The campaign is over, as has been said by many others already.

[Inaudible interjection]

Mr. Kenneth V. Bryan: Sorry, three Independent Members.

The campaign is over and like I have said throughout my campaign, my ultimate goal is to get whatever is in the best interest of the Cayman Islands and in particular for George Town Central. I promise this Administration to give the support when necessary and to the Opposition when necessary.

Thankfully to the wisdom of the Members of which I am with in the Opposition and the guidance, I understand the role of being an Opposition Member, and it is a very important one to the democratic process. But I can promise you I will not be opposing just for opposition sake. There will be many times that I will vote 'yes' in your favour; at least I hope so. But in the event that I do oppose, it is because it is the will of the people of George Town Central because I intend to keep good communication with them throughout these four years to act on their behalf, not my own.

I want to say to all of the young people of the Cayman Islands, that my colleague, Alva Suckoo, and I, promises to give you a voice in this Legislative Assembly and that that voice will never be turned down. I will continue to fight for you no matter what.

Thank you to all of the other candidates in this election who, unfortunately, were unsuccessful in becoming a part of the Legislative Assembly. Again, I would like to say in regards to Mr. Speaker, that in respect to our relationship, many have suggested that I was a part of the CDP Party secretly but I am a wise person to see that where there is wisdom, never to be afraid to ask and learn,

just as much as I would ask our Honourable Premier, Mr. Alden McLaughlin. And though the journey to get where I am today has been a mighty fight, I learnt this morning that the fight was well worth it just to get one word from somebody who means something to me.

Mr. Christopher S. Saunders, Elected Member for Bodden Town West: Thank you, Mr. Speaker.

First and foremost, all praises to God. His son the Carpenter from Galilee taught us in Matthew chapter 6, verse 33: "Seek ye first the Kingdom of God and His righteousness, and those things shall be added unto you."

I have to say a special thank you to my family, particularly my wife who held the family together that gave me peace of mind to campaign. I have to also say a special thank you to my mother who went door to door with me and pushed me even when I was tired. I also have to say a special thank you to my big sister, Karlene [PHONETIC], who flew from the UK a total of three times in six weeks to help me campaign. There were times when it was late and we were tired and she would always say—*Just one more house*.

Mr. Speaker, I must say a big thank you to the voters in my home District of Bodden Town West who trusted me with their votes to make their lives better. Many of them lifted me up in prayers, invited me to their homes, and made me feel welcome. Of the votes that I received, one is also very special to me, as I had a constituent who lost her husband and in her time of grief she went out to vote. When I went to visit her house during the campaign she was not at home but I met the husband instead and was shocked of his untimely passing. I asked this House and everyone else to remember the family of the late Albert Seymour in their prayers.

Mr. Speaker, I also want my constituents of Bodden Town West to know that despite my unconventional campaign where I only had one meeting, no television ads, no radio ads, no donations, that they should not be troubled by where I chose to sit in this honourable House. As you can see, there were no games played here from this side of the House and we want all and sundry to know that we intend to represent the people of Bodden Town West with class. Not just Bodden Town East have class my friend, we have class in Bodden Town West too. So, it is with class, professionalism and integrity. I told my family

that I would never ever embarrass them and I pass that comment on down to my constituents also.

I would also like to thank on record Mr. Wayne Panton and Osbourne Bodden for their service to the Bodden Town community. They spent four years here and despite the results at the polls, I think at the end of the day once you have put service into this country, it is something that we should always be thankful and recognise whenever we can.

I must also say a special thank you to Mr. Gilbert McLean, one of my opponents who has served this country well and I am really sorry I had to go up against him having been a supporter in the past, but he is a good man and I really hope to—not just myself but others inside here—reach out to him and draw on his counsel.

Mr. Speaker, my wife insisted that I put this part in, so I have to apologise to you for my frankness during our discussions. I did not realise until I saw it on Facebook that it bothered you and I want you to know it was nothing personal. I consider you a friend. You are a great friend of the family and I would like to make sure our relationship continues in that regard, so, congratulations on your role as Speaker.

Mr. Premier, I also want to thank you for what you have done and how you have gone about to pull this country together. I can give the Government Bench my support and commitment that I will not just oppose for opposing sake, because at the end of the day every single one of us were elected here to make peoples' lives better and any other assistance I can offer technically or otherwise, please feel free to call on me. I give my commitment for that. I mean, after all, election is a competition of ideas and ideology. And this House was designed for us to have debate and through debate we find consensus.

Mr. Speaker, there is an old political story which you have probably heard of because you have been around a long time, where Napoleon was once asked to explain the absence of great statesmen in France, to which Napoleon replied that in order to obtain power, one has to show pettiness, and in order to exercise power, one has to show greatness. You cannot obtain power in a petty way and be great. Either you are petty or you are great. And I want to give everyone here, my commitment that I have no intention of being petty. So, I just wanted to put that out there.

Mr. Speaker, next year will be 80 years since my grandmother, the late Ms. Mc [PHONETIC] of Champion House first arrived in these Islands. She raised 10 children, one of whom is George McCarthy who is no stranger to this honourable House, having served this country as both the Financial Secretary and Chief Secretary, and I was really pleased to see him here this morning. I believe that I am probably the first second generation Caymanian to serve in this House and despite my last name not being traditional or my accent not being traditional, I just want everyone to know that this is my home. I have nowhere else

to go, nor would I wish to be anywhere else. If there is one thing that my travels and all of my overseas education have made me appreciate, is my home more than anything. And having seen what has happened in other countries I am determined to make sure it does not happen here. So, I just wanted to get that out there also.

My home District of Bodden Town West like many other places on Island, there are thousands of second-generation Caymanians and newer Caymanians. I believe that my election to this honourable House is a step forward in this country that despite whence we came, we are all now Caymanians. I have heard it said many times that Chris won because of the Jamaican vote. No, Mr. Speaker, Chris won because of the Caymanian vote. The only people who are allowed to vote in our elections are the Caymanians and if we are truly to move our Islands forward, everyone in this House must accept that whether your family came 200 years ago, 80 years ago or 20 years ago, we are all Caymanians.

I challenge the Government to work together, not just to create politicians for national unity, but a people of national unity. No matter what ideas or plans we have, it means nothing if the people are not united. This Government can therefore count on my support to do whatever is required for the people to be united, thus my campaign slogan "Forward together".

Mr. Speaker, I am hoping that with God's help that I will live four more years and as such, I will have many opportunities to speak. I don't want to be remembered for having a long drawn out speech the first time I spoke in this House, so I would like to close with the following Bible verse as it is one of my mother's favourite. It comes from 2 Chronicles 7:14—"If my people, which are called by my name, shall humble themselves, and pray, and seek my face, turn from their wicked ways; then I will hear from heaven, and will forgive their sins and heal their land."

I therefore ask all Members of this honourable House to humble themselves, pray, seek God, so that our land can be healed.

The Speaker: Thank you, honourable Member.

I recognise the Member for George Town South.

Ms. Barbara E. Conolly, Elected Member for George Town South: Thank you, Mr. Speaker, for this opportunity.

I rise in this honourable Chamber for the very first time, with a full and thankful heart as the Member for George Town South. I wish from the outset to place on record my thanks to the electorate of George Town South for their trust in me as their representative. I shall always honour that trust.

I am the first person to be elected by the voters of George Town South in the new single member dispensation and I give my assurance to them and to this honourable House that I intend to set high standards of representation. In this regard, Mr. Speaker, I will be guided by the example of my immediate predecessor, [the Honourable] D. Kurt Tibbetts, whose representation of George Town as a single district is legendary. I feel privileged to be in this Chamber to influence legislative changes that impact positively on the lives of Caymanians. I am equally honoured to do so as a woman, certainly, in the knowledge that we bring a different perspective to national life.

It would be remiss of me if I did not thank my campaign team who gave up their own commitments to pound the pavements with me; knocked on doors, organised small gatherings, enlist to the support of their family, friends and co-workers, and generally give me the moral support needed for such an endeavor. The backing of my political organisation was also outstanding and I thank everyone, including my fellow candidates for their help, hard work and inspiration.

On a more personal note, I must also thank my children, grandchildren and siblings for being so generous with their time and understanding for what promises to be an amazing new experience in my life. I look forward to healthy, respectful debate on the many matters that will require the attention of this Legislative Assembly over the next four years. And I thank you and the House for your indulgence.

Thank you, Mr. Speaker, and, may God bless these Islands we call home.

The Speaker: Thank you, honourable Member. Member for George Town West.

Mr. David C. Wight, Elected Member for George Town West: Mr. Speaker, I want to thank you for giving me this opportunity to address this honourable House.

Firstly, I want to thank my Almighty God for His blessings, for nothing is possible without Him.

Today is without doubt the greatest day of my life but it is bitter/sweet because of the absence of my parents, Derek and Marguerite Wight. I take comfort in knowing they are looking down and smiling proudly.

I would like to acknowledge my daughter, Delecia [PHONETIC], who spent all day with me, and even though she has not said it, I think she is proud of me.

If someone had told me three months ago that I would be standing here in this most honourable House, giving an acceptance speech as an elected Member of the Legislative Assembly, I would never have believed them. To be chosen as an elected Member of this Assembly by the voters in the constituency of George Town West is the greatest honour I can imagine. The last eight weeks has involved very hard work but the many friends who put themselves on the line for our country through me, made the work so much easier. I am truly grateful to the constituents of my District for placing their trust in me, especially those who put in at least as much work as I did.

I would also like to thank all of my family and my Progressive family from the Honourable Premier, Alden McLaughlin, right down, who had confidence in me and who supported my efforts and put in a lot of work during my campaign. I truly appreciate it.

I would like to say a special 'thank you' to three former elected Members of Government—Mr. Norman Bodden, who is the first person I ever voted for; Mr. Linford Pierson whom I supported from the beginning of his political career, and the Honourable D. Kurt Tibbetts whom I have supported since 1988 and who has been my mentor since 2001, but especially, one who has guided Barbara and I during this election campaign.

Mr. Speaker, I am very aware that by choosing me, the voters have placed a great responsibility on me, one which I take very seriously. I will always remember that you have put your trust in me by electing me and I will always act in a manner which makes you proud to call me your representative.

One of the first tasks will address will be the formation of a District Council representing George Town West, giving me the ability to work with my constituents to address all of the issues of our district. This will give everyone an opportunity to have their say in important issues facing our district. Together we will work to make George Town West better for everyone.

Mr. Speaker, I thank you again for allowing me this opportunity to speak in this honourable House to address the people of Cayman for the first time as an elected Member. I look forward to working with everyone in this House and I make a special plea that all in this House put our hands together and work for the betterment of our beloved Cayman Islands.

The Speaker: Thank you, honourable Member.

Does any other Member wish to speak?

Honourable Member for West Bay South.

Hon. Tara A. Rivers, Elected Member for West Bay South: Thank you, Mr. Speaker.

Mr. Speaker, I first would also like to thank God for all of His blessings, His mercies, His grace and for giving me the opportunity to stand here (I certainly would not want to go as far as to say 'seasoned position') as a second-term elected representative, firstly, for the District of West Bay and now in the capacity as a representative for the District of West Bay South under this new dispensation.

I am so eternally grateful for all the persons who participated in this first ever elections under our new electoral system and I am eternally grateful for the resounding support shown to me by the constituents of West Bay South. And for that I would like to say publicly, a big thank you to all of those whom I may not have had the opportunity to say to in person thus far.

Mr. Speaker, I would also like to say a big thank you to my family that has been a tremendous support throughout all of this, and in particular, my mom who is here and who has been here every step of the way. She is my rock, she is my campaign manager extraordinaire, and, as I said on many occasions, it is a good thing she is family because I could never afford the services that she has rendered during this particular campaign. And although I did send him off to school eventually today, I want to acknowledge and recognise my precious son who also was second in command in campaign central for West Bay South.

Certainly, Mr. Speaker, as many people have recognised, it is certainly not by our own efforts that we were successful in standing here as elected representatives for our distinct electoral districts. If it were not for the very hard work and commitment and determination of our committees—and I certainly want to echo my heartfelt gratitude and how humbled I am that so many people came out in the form of a com-

mittee, in the form of volunteers, in the form of supporters that took their time, energy and effort to see to it that I was successful once again to grace these Hallowed Halls on behalf of the constituents of West Bay South in particular, but on behalf of the people of the Cayman Islands as a whole. And so, I want to say a big thank you and I would not even attempt to name them by name because for fear of leaving out anyone in particular at this stage. But you know who you are. Some of them are still here today and have been here from morning and will be hearing the sound of my voice when they listen or view this rebroadcast.

I also want to take time to recognise a family, as we heard from the Member for Bodden Town West that lost a loved one during the thick of things. Actually, I think it was two or three days before (it may have been closer to a week) before the elections itself. It is the family of the late Phyllis Rudon [PHONETIC] who, even though they have grieved and I am sure are still grieving, came out and showed their support and was there every step of the way at the public meetings and up until this very day I got a call from Mr. Herald Rudon [PHONETIC] asking and inquiring how I was doing and if I was doing okay.

It really brought it home to me how many people are praying for us, have been praying for me and how many people believe in us that even during their time of grief they want to still know that the country is going to be all right and that we are going to do what we set out to do, and that is to represent the people of this country to the best of our ability.

Mr. Speaker, as a second-term MLA, certainly, there is still so much to learn but I am very grateful for the experiences that I have had during the previous term. I am not only a second-term MLA but I am also grateful for the opportunity to serve as a second-term Minister in this firmly established coalition Government.

Mr. Speaker, I gave a commitment to the people of West Bay in 2013 and to the country as a whole, to serve the people to the best of my ability and in the best interest of the country with whomever they wanted me to work with, to serve with. I campaigned as an Independent then and I campaigned as an Independent now. And I believe it is important that we recognise that being independent means that you have your own independent mind to decide where you think you are best placed to serve, given the mandate that you have been given. And certainly, Mr. Speaker, I am very grateful for the opportunity to continue to serve with the Government. I will do so with diligence, the tenacity, with the ability to stand and speak up when necessary for my people. We are one and West Bay South in particular, Mr. Speaker, is certainly one of those constituencies that have a wide variety of Caymanians represented as a part of that constituency. It is not only the

largest constituency by geography, it is certainly one of the largest by demography, by composition and it is a privilege for me to have been given the honour to serve the interest of the people of West Bay South, but as I said, the country as a whole.

Mr. Speaker, we have an unprecedented composition in this Government, in this Parliament, in this Legislative Assembly right now. We are the first legislators that have been returned as representatives of the single member constituencies; the 19 single member constituencies of which we are here today.

We also have an unprecedented composition of Members on the Government Bench. We have Members of the Progressive, we have Members of the CDP and we have Independent Members who were elected, as I said, to demonstrate their independence to choose and make the best choice that they think is right for the people of this country. So, Mr. Speaker, that representation of National Unity should not be lost of the significance of what we have achieved thus far and what the people are expecting us to achieve.

Mr. Speaker, we also have an unprecedented composition as it relates to the Cabinet. This is the first time, I believe, we have had and will have two women serving in Cabinet in the history of this country. And again, I think that should not be lost on the country as a whole. We are moving forward in so many ways, and I want to just again acknowledge and thank the people of West Bay South for giving me the opportunity to be one of them.

Mr. Speaker, in closing I would like to say that we need to come together, not just as representatives in this symbolic way, but we need to continue to work together for the betterment of our people. We need to resist whatever temptations there may be to undermine one another. We need to be able to show the country that we really can put country first. Irrespective of how we got here, irrespective of what parties we represent or not, we are here to serve the people and I certainly will do my part as I have done in the past administration to make sure that all of the work and effort and achievements that we have been able to achieve thus far, will continue to progress going forward as the people expect us to do.

The Speaker: Honourable Minister, when I call you I expect you to answer now since we are one.

[Laughter]

The Speaker: She is my cuz.

Does any other Member wish to speak? Elected Member for West Bay North.

Hon. Bernie A. Bush, Deputy Speaker, Elected Member for West Bay North: Mr. Speaker, I think I will demonstrate what the Premier asked for, a short [speech].

Everyone knows where I sit I am uncomfortable. Everyone knows why I am doing this, is because it has to be for my people.

Mr. Speaker, I intend to be the watchman for fairness and development of our people. I will not be a part or support of any group that turns a blind eye to allegations of impropriety against young people engaged in sporting activities or any other endeavor.

Mr. Speaker, on Thursday I took some pictures of a classroom in West Bay Primary [School]. I did not go to the social media with it and I intend that as soon as the Premier announces the Members of Cabinet, to request two things for my West Bay Primary School; and one is that a new block be built because the present block is no good. I personally paid for an air test two years ago and it showed up pretty good. We then found it was under the floor and now we are finding it in the walls and now we have vermin in the roof.

Mr. Speaker, earlier the Deputy Governor said something like I can't say anything because I am on the Government side [INAUDIBLE]. Well, if the Deputy Governor thinks that debacles like the Fire Chief and such things will go unvoiced because I am sitting here—

[Inaudible interjection]

Hon. Bernie A. Bush: This is not the day for it sir. The Premier wants it to be short.

It will be those types of things when I find them I will bring here regardless of where I sit, because, like I said, I intend for the next four years to be a voice for injustice and for fairness. Throughout this country if you want to call it racism or you want to call it anti-Caymanism, whatever you desire to call it, the people are screaming for it, that this is going on and no one is speaking about it. It will be spoken to a lot once the evidence is here.

Mr. Speaker, in closing, praise be to God. He saw fit to put us here. To the people of West Bay North, thank you. The work starts in a few weeks and we are going to do what we have to do.

To the newcomers, I am also a second-term Member. I looked at who came before me and I looked at some that left before me. One thing I will say is, stay humble, stay respectful, and do not be pompous. A lot of those who seem to come with such [attitudes] have gone by the wayside. When I first came here, the Member for East End said to all the new people "chart your own course". I give the same advice. Whichever side you sit, there is a man with not much hair from Savannah on that side, he is a wealth of wisdom and calmness, use him.

Mr. Speaker, thank you very much.

The Speaker: Does any other Member wish to speak?

Elected Member for West Bay Central.

Capt. A. Eugene Ebanks, Elected Member for West Bay Central: Thank you, Mr. Speaker.

Firstly, I would like to thank God Almighty for allowing me the privilege to come back to this honourable House.

I want to thank the people of West Bay, especially the people of West Bay Central for allowing me to serve them for a fifth consecutive term. I am forever indebted to them for their support. I thank my family and I know some of the Members have mentioned their committees but I can honestly say that there is no committee that is more dedicated than my committee. They are the best of the best.

I promise the people of West Bay Central to be as dedicated in serving them as best as I can, as I have done for the last 16 plus years. So, this term should be even more interesting since I only have less than 1,100 people to pay closer attention to. However, I represent the entire District of West Bay and the Island, but especially the West Bay Central people. I want to thank them once again. It has been an honour and a privilege to serve them, and I will continue to the best of my ability.

Thank you, Mr. Speaker.

The Speaker: Thank you very much, honourable Member.

Does any other Member wish to speak? [pause] Does any other Member wish to speak? [pause]

If not, I call on the Premier to move the adjournment of the House.

[Inaudible interjection]

The Speaker: I should ask though, as when we go to prayer meetings; at least, years ago they used to ask, "Are all hearts clear?"

Honourable Members, allow me to thank my people for again their support of myself; the hard workers of the new constituency of West Bay West, all of them, especially, Mr. Ashton Ebanks, my Chairman, and his deputy, Mr. Jerry Ebanks, and others.

I do want to especially thank our young CDPs and other young people who worked so very hard in the elections. And, honourable Members, I am sure that you are happy as I am, to have seen so many young people get involved after so much discouragement by people who are saying that everything is bad, everything is going to pieces. The young people came out and were a part and I am very proud of that. My cousin, Eva, and others, were the backbone of my campaign. I did not have time to be much in my constituency but I do want to thank our district committee also for their hard work.

Indeed, I wish to thank my Party colleagues and the wider country for the trust they put in me. I am humbled to receive the top votes in these Islands of over 71 per cent of those who voted.

I am thankful to my loving wife of 42 years, my only son and my sisters and brothers and other family members.

I have one thing to say—we are a Unity Government and we strive for unity in this House, but I must say this, whether you take it politically or not, I don't think the Party systems that this country returned—what?—eleven of us. Well, some may say 10 but I say my cousin is part of us. She is one of us. Eleven of us and together our votes were stronger than the Independents. So, it shows that the country still has faith in organisation, and in the Party system. There is no question about that.

Having said that, we are happy for the Independent Members who worked hard and made their way forward. Some had very little meetings and we have to acknowledge that and say thanks to the people because it is our democracy. We can do it, honourable Members. I trust him and I know God will make a way for us
