Re: Update – 2024 Adult and Juvenile Caution Report

Dear Hon. Attorney General,

The purpose of this document is to identify data on adult and juvenile cautions in 2024. Data as at 15th January 2026.

Key Findings

- There was a total of **29** adult and juvenile cautions in 2024. Of that **21** were adult cautions and **8** were juvenile cautions.
