### THE IMMIGRATION (TRANSITION) ACT (2022 REVISION)

### The Immigration (Transition) (Grant of the Right to be Caymanian) Order, 2026

**WHEREAS** section 26(1)(e) of the Immigration (Transition) Act (2022 Revision) provides that the Cabinet, acting upon the recommendation of the Caymanian Status and Permanent Residency Board, may grant the right to be Caymanian in accordance with the section;

**AND WHEREAS** at their meeting on 15 April 2026, Cabinet granted Ms. Crystal Casandra Edwards the right to be Caymanian, pursuant to section 26(1)(e);

**AND WHEREAS** section 26(1)(e) provides that such grant requires ratification by the Cayman Islands Parliament;

**AND WHEREAS** the Immigration (Transition) (Grant of the Right to be Caymanian) Order, 2026 was laid on the Table of the Parliament;

**BE IT THEREFORE RESOLVED THAT** the Immigration (Transition) (Grant of the Right to be Caymanian) Order, 2026 be ratified by the Parliament pursuant to the provisions of section 26(1)(e) of the Immigration (Transition) Act (2022 Revision).

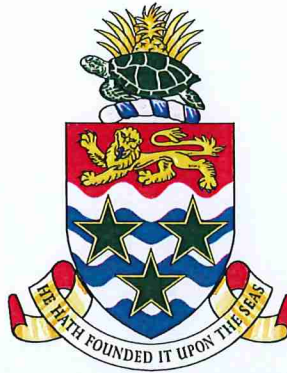
